LANDSCAPE IMPROVEMENTS UNDERWAY

THE FIRST PART OF THE DISTRICT'S CAPITAL **IMPROVEMENT** PROGRAM HAS BEEN COMPLETED. THROUGHOUT CORAL BAY, TRAFFIC ISLANDS HAVE BEEN RE-LANDSCAPED WITH DROUGHT-TOLERANT PLANTS. THESE AREAS WILL BE HAND WATERED FOR SEVERAL WEEKS UNTIL THE PLANTS ARE ESTABLISHED AND THE SUMMER RAINY SEASON BEGINS.

THE PLANTS WERE
CHOSEN FOR THEIR
COLOR AND THEIR LOW
WATER REQUIREMENTS.
MOST OF THE TRAFFIC
ISLANDS LACK
IRRIGATION AND THE
COST TO INSTALL AND
MAINTAIN IRRIGATION

SYSTEMS AT THOSE LOCATIONS WOULD BE COST PROHIBITIVE.

THE PLANTINGS ARE SLOW GROWING VARIETIES THAT SHOULD ADAPT WELL TO THEIR LOCATIONS. THEY WILL TAKE SEVERAL MONTHS TO REACH A MATURE HEIGHT.

NAUTICAL LANDSCAPE
BOLLARDS WERE ALSO
INSTALLED TO MAKE THE
COMMUNITY MORE
HOMOGENOUS IN
APPEARANCE AND TO
DISCOURAGE
VEHICULAR PARKING
AROUND THE TRAFFIC
ISLANDS. PARKING IS
NEVER ALLOWED NEXT
TO TRAFFIC ISLANDS.
THE NEXT PHASE OF
LANDSCAPE

IMPROVEMENTS SHOULD BE UNDERWAY BY THE TIME YOU RECEIVE THIS NEWSLETTER.

THE DISTRICT, WITH FINANCIAL ASSISTANCE FROM THE COUNTY'S BROWARD BEAUTIFUL PROGRAM, WILL BE **INSTALLING** LANDSCAPING FROM THE LIFT STATION ON NORTH BAY DRIVE TO A POINT WEST OF SOUTHWIND LANE. THIS LANDSCAPING IS **DESIGNED TO SHIELD** CORAL BAY FROM THE MULTIFAMILY COMPLEX AND WILL ALSO ADD SOME COLOR AND INTEREST TO THAT PART OF THE COMMUNITY.

FAY'S COVE POOL TO BE CLOSED FOR RENOVATIONS

THE FAY'S COVE POOL LOCATED AT THE END OF SOUTHWIND LANE WILL BE CLOSED FOR A LITTLE OVER TWO MONTHS SO THAT THE POOL CAN BE DRAINED AND A LEAK CAUSED BY A BROKEN POOL BEAM CAN BE FIXED. ALSO DURING THIS TIME, THE BATHROOMS THAT HAVE BEEN VANDALIZED WILL BE RENOVATED WITH

FINISHES THAT ARE EASIER TO MAINTAIN AND THAT ARE MORE RESISTANT TO VANDALISM.

VANDALISM HAS BEEN A CONSTANT PROBLEM AT THIS POOL AREA AND THE DISTRICT HAS STEPPED UP SECURITY AND POLICE PATROLS.

WE ARE ASKING FOR YOUR HELP IN MONITORING ACTIVITY AT THIS POOL AREA. SHOULD YOU SEE ANY SUSPICIOUS ACTIVITY, PLEASE CALL THE MARGATE POLICE DEPARTMENT OR THE GUARDHOUSE.

WE EXPECT TO HAVE THE POOL REOPENED IN TIME FOR SUMMER. PAGE 2 OF 4 CORAL BAY BUZZ

THE EXISTING WOOD SHADOWBOX FENCE WILL BE REPLACED WITH A SOLID CONCRETE PANEL SYSTEM. THE NEW CONCRETE PANEL FENCE WILL BE SIX FEET IN HEIGHT. THE SAME HEIGHT AS THE CURRENT FENCE. THE CONCRETE PANEL FENCE HAS AN INDEFINITE LIFE EXPECTANCY. PROVIDES SOUND ABATEMENT AND MORE PRIVACY FOR

FENCING PROJECT TO BEGIN SHORTLY EXISTING FENCE TO BE REMOVED

THE DISTRICT IS **EXPECTED TO BEGIN** CONSTRUCTION OF THE CONCRETE FENCING SYSTEM IN THE VERY NEAR FUTURE. THE **EXISTING FENCE WILL** BE REMOVED AND A **TEMPORARY** SCREENED CHAIN LINK FENCE WILL BE INSTALLED. HOMEOWNERS WHO HAVE NOT YET RETURNED THEIR **EXECUTED EASEMENT** AGREEMENTS TO THE DISTRICT WILL LIKELY NOT HAVE A TEMPORARY FENCE **INSTALLED ON THEIR** PROPERTY. FOR THOSE HOMEOWNERS, THEY SHOULD KEEP SMALL CHILDREN AND ANIMALS INSIDE AND

AWAY FROM THE TRAFFIC ON BAY DRIVE. IF YOU DID NOT RECEIVE AN EASEMENT AGREEMENT, PLEASE CALL THE DISTRICT OFFICE AS SOON AS POSSIBLE.

THE DISTRICT IS
EXPECTED TO RECEIVE
AN ASSIGNMENT OF
RIGHTS ON AN EXISTING
EASEMENT ON THE
AFFECTED PROPERTIES.

IF YOU HAVE CONCERNS ABOUT POSSIBLE CONFLICTS DURING OUR CONSTRUCTION PERIOD, PLEASE CONTACT THE DISTRICT OFFICES AT YOUR EARLIEST CONVENIENCE.

THE FIRST TWO PHASES WILL BE ON SOUTH BAY DRIVE AND WILL ABUT

HOMES IN THE LAS BRISAS DEL MAR, LAS BRISAS, AND MALLORY HARBOR COMMUNITIES.

DURING THIS FIRST
PHASE OF
CONSTRUCTION, PARTS
OF SOUTH BAY DRIVE
WILL CLOSED DURING
THE DAY AND ONLY
THOSE PEOPLE WHO
LIVE IN THOSE
COMMUNITIES WILL BE
ABLE TO USE SOUTH
BAY DRIVE. IT WILL BE
CLOSED OFF FROM THE
BACK GATE. THIS WILL
OCCUR ONLY DURING
THE DAY.

GUARDHOUSE TO BE CLOSED DURING THE DAY FOR THE FIRST PHASES OF THE FENCE CONSTRUCTION

DURING THE FIRST TWO PHASES OF FENCE CONSTRUCTION, THE GUARDHOUSE ON SOUTH BAY DRIVE WILL BE CLOSED WEEKDAYS FROM 7:00 A.M. TO 7:00 P.M. AS IT WILL BE NECESSARY TO LEAVE THE NORTH BAY DRIVE GATES OPEN DURING THESE TIMES TO PROVIDE ACCESS TO PARTS OF CORAL BAY, THE GUARDHOUSE IS BEING CLOSED AS A COST CUTTING MEASURE. ON WEEKENDS AND WEEKDAYS AFTER 7:00 P.M., THE GUARDHOUSE WILL BE OPERATIONAL, AS WILL BE THE NORTH BAY DRIVE GATES.

TRAFFIC BARRICADES AND DETOURS WILL BE ERECTED DURING THE CONSTRUCTION PERIOD. THE DISTRICT HAS BEEN WORKING WITH THE SCHOOL BOARD TO COORDINATE ANY NECESSARY CHANGES TO BUS ROUTES AND STOPS.

NORTH BAY DRIVE TO BE MADE A "RESIDENT'S ONLY" ENTRANCE

BOARD VOTES TO INSTALL SWING GATES AND ELIMINATE VISITORS ACCESS

AFTER TRYING DIFFERENT TACTICS TO CURB VANDALISM AT THE NORTH BAY DRIVE ENTRANCE, AND HAVING RECEIVED INPUT FROM A RECENT RESIDENT SURVEY, THE BOARD DECIDED AT ITS MARCH MEETING TO ACCEPT A PROPOSAL TO CLOSE NORTH BAY DRIVE TO VISITORS AND TO **INSTALL SWING GATES** SIMILAR TO THOSE AT THE BACK GATE. TO FUND THIS IMPROVEMENT, THE

BOARD WILL USE SOME OF THE SAVINGS FROM THE SCALED-BACK GUARDHOUSE OPERATION THAT IS FURTHER DESCRIBED ON A PAGE 2 ARTICLE.

NORTH BAY DRIVE AT THE GATES WILL BE REDUCED TO ONE LANE IN FOR RESIDENTS ONLY AND ONE WAY OUT FOR ALL TRAFFIC. THE CALL BOX WILL BE ELIMINATED AND VISITORS WILL BE REQUIRED TO ENTER THROUGH THE

GUARDHOUSE GATE.
TRAFFIC STUDIES
SUGGEST THAT ACCESS
AT THE GUARDHOUSE
SHOULD NOT BE
OVERBURDENED.
RESIDENTS SHOULD
START INFORMING THEIR
REGULAR GUESTS OF
THIS CHANGE. THE GATE
SHOULD BE INSTALLED
BY THE END OF MAY.

VANDALS CAUGHT FINANCIAL RECOVERY MADE

THE DISTRICT HAS RECOVERED NEARLY \$3,000 FOR ACTS OF VANDALISM OF DISTRICT PROPERTY OVER THE LAST SEVERAL MONTHS AND IS ACTIVELY PURSUING OTHERS WHO HAVE BEEN CAUGHT DAMAGING ITS PROPERTY. MONEY HAS BEEN COLLECTED IN FROM THOSE WHO HAVE BROKEN STREETLIGHTS, DAMAGED POOL AREAS, AND BROKEN GATES AND GATE ARMS.

TWO INSTANCES HAVE RESULTED IN CRIMINAL PROSECUTIONS BY THE STATE ATTORNEY'S OFFICE AND ONE CORAL BAY RESIDENT IS BEING SUED IN CIVIL COURT FOR DAMAGE CAUSED TO ONE OF THE DISTRICT'S GATES AND FOR WHICH THE VEHICLE'S OWNER REFUSES TO PAY FOR THE DAMAGES. THE CHANCE OF FINANCIAL RECOVERY OF ALL ITS COSTS, INCLUDING LEGAL FEES, IS VERY GOOD.

WITH ONE EXCEPTION, THE SAME PERSONS DO NOT DO MOST ACTS OF VANDALISM TO THE DISTRICT'S GATES. VISITORS AND RESIDENTS HAVE BEEN OBSERVED ON SURVEILLANCE VIDEO DAMAGING THE DISTRICT'S PROPERTY. MANY TIMES, THESE ACTS ARE DELIBERATE

THE DISTRICT OFFERS A \$250 REWARD FOR INFORMATION THAT LEADS TO THE ARREST AND CONVICTION OF PERSONS WHO HAVE DAMAGED THE DISTRICT'S PROPERTY. PLEASE CONTACT THE DISTRICT OFFICE OR THE MARGATE POLICE DEPARTMENT WHEN YOU HAVE INFORMATION THAT CAN HELP.

lT'S CROCODILE MATING SEASON. PLEASE BE MINDFUL OF YOUR PETS AND **CHILDREN** WHEN THEY ARE OUTDOORS. IF YOU SEE AN ALLIGATOR, CALL THE POLICE OR THE FISH AND WILDLIFE COMMISSION
