
**CORAL BAY COMMUNITY DEVELOPMENT DISTRICT
MINUTES OF THE REGULAR MEETING OF THE BOARD OF SUPERVISORS
February 9, 2006**

1. **Roll Call.** Chairman John Hall called the meeting to order at 7:00 p.m. Also present were Vice-Chair Sandra McCormick, Supervisors Fred Bourdin, Dan Dean, and Tony Spavento, District Manager Dr. Irving Rosenbaum, Secretary Christopher Wallace, District Engineer Jim Mullen and Treasurer Tina Hagen.

3. **Approval of Minutes.**
 - a. **January 12, 2006 minutes.**
 - b. **December 10, 2005 minutes.** The Board discussed several changes to both minutes. Supervisor Bourdin moved to accept the amended minutes and Supervisor Dean seconded the motion.
